

KAMBA - END USER LICENCE AGREEMENT

IMPORTANT. READ CAREFULLY:

This End User License Agreement (**EULA**) is a legal agreement between you and the entity or company that you represent (**you** or **your**) and Thales Australia Limited (ABN 66 008 642 751) (**Thales Australia**) for the Kamba application (**App**) created and developed by Thales Australia.

PLEASE READ THIS EULA CAREFULLY BEFORE USING THE APP OR DOWNLOADING THE UPDATES (AS DEFINED BELOW) ACCOMPANYING THIS EULA. BY USING THE APP OR UPDATES, AS APPLICABLE, YOU ARE AGREEING TO BE BOUND BY THE TERMS OF THIS EULA. IF YOU DO NOT AGREE TO THE TERMS OF THIS EULA, DO NOT USE THE APP OR DOWNLOAD THE UPDATES.

Thales Australia may from time to time update this EULA, including as a result of changes to legislation or business requirements. You must acknowledge and agree with the updated EULA to continue accessing and using the App.

1. COMPATIBILITY.

You acknowledge and agree that the App is designed for use on the Atlassian Marketplace (<http://marketplace.atlassian.com>) and that this EULA is between you and Thales Australia only, and not Atlassian Pty Ltd (ABN 53 102 443 916) (**Atlassian**). Thales Australia, and not Atlassian, is solely responsible for the App, provision of support services and responding to your complaints. Atlassian will not be responsible for, and will have no liability whatsoever, under this EULA.

2. GRANT OF LICENCE.

Thales Australia grant you a limited non-exclusive, non-transferable, non-sublicensable, revocable, licence to download, install and use the App in accordance with this EULA. This licence is subject to you having a current and fully paid up licence. The duration and fee for the licence is as specified on the Atlassian Marketplace. This licence to download, install and use the App does not, and is not intended to, grant you any interest or right with respect to all industrial and intellectual property rights of any kind including but not limited to copyright, patents, trademarks, design, moral rights and other proprietary rights and all rights or forms of protection of a similar nature or having equivalent or similar effect to any of these which may subsist anywhere in the world (**Intellectual Property Rights**) in the App.

You will not (except to the extent permitted by law that cannot be excluded):

- (a) copy, modify, enhance or reproduce the App or licence key (if any), in whole or in part (other than as expressly set out in this EULA);
- (b) create derivative works based on the App;
- (c) reverse-engineer, reverse-translate, disassemble, de-compile, or otherwise attempt to derive source code to the App;
- (d) sell, distribute or in any way exploit the App;
- (e) rent, lease, lend, sublicense or provide commercial hosting services with the App;
- (a) use the App in violation of the terms of this EULA or any law, regulation or rule;
- (f) transfer this EULA or the rights to the App granted herein to any third party;
- (g) incorporate, embed, combine, merge or bundle the App with any other hardware or software (except to the extent strictly necessary to use the App in accordance with its intended purpose and this EULA);
- (h) use the App to violate the security or integrity of any network, computer or communications system, software application, or network or computing device;
- (i) use any Thales Australia services associated with the App in any manner that could modify, interfere with, damage, disable, overburden, or impair such services or interfere with any other party's use and enjoyment of the them, including that of Atlassian and/or other end users of the Atlassian Marketplace;

- (j) use any unauthorised third-party software that intercepts, mines, or otherwise collects information from or through the App, or facilitate, create or maintain any unauthorised connection to the App;
- (k) use the App for any illegal, harmful, fraudulent, infringing or offensive use, or to transmit, store, display, distribute or otherwise make available content that is illegal, harmful, fraudulent, infringing or offensive;
- (l) remove or obscure any proprietary notices on the App;
- (m) use the App to infringe the intellectual property or proprietary rights, or rights of publicity or privacy, of any third party;
- (n) to disseminate, transfer or store information or materials in any form or format that are harmful, threatening, abusive, harassing, tortious, defamatory, vulgar, obscene, libelous, or otherwise objectionable or that otherwise violate any law or right of any third party;
- (o) use the App in any way that violates this EULA, any Law, or the rights of any third party; and/or
- (p) directly or indirectly permit or assist any third party to do any of the above.

Where the App is being used by your employee or other person using the App as part of your undertaking (**Your Staff**), that member of Your Staff is licensed to use the App as if it were you and must comply with this EULA on the same basis. Any failure to comply with this EULA by Your Staff will be deemed to be a failure by you to comply with this EULA.

If you become aware of any infringement or suspected infringement by any third party of any Intellectual Property Rights in the App, you must immediately notify Thales Australia. You must at Thales Australia's request and expense take any action as Thales Australia deem is appropriate to protect Thales Australia's Intellectual Property Rights.

3. RESERVATION OF RIGHTS AND OWNERSHIP.

Thales Australia reserves all rights not expressly granted to you in this EULA, including all Intellectual Property Rights in the object code and source code of the App. The App is protected by copyright and other intellectual property laws and treaties. Thales Australia or its licensors own all the Intellectual Property Rights in the App. The App is licensed, not sold.

If you provide feedback or an enquiry to Thales Australia through the App or otherwise, you grant Thales Australia a worldwide perpetual irrevocable licence to use and disseminate your feedback or enquiry for the purpose of improving Thales Australia services.

4. CONTENT.

You, not Thales Australia, remain solely responsible for all information or materials in any form or format that you upload, post, transmit, or otherwise disseminate using, or in connection with, the App. You access such content at your own risk and you will be solely responsible for any damage or liability to any party resulting from such access.

5. FEES AND PAYMENT.

You must pay Atlassian the fees, including all taxes, indicated at the time of your order. Please refer to the Atlassian Marketplace Terms of Use for more information available at <https://www.atlassian.com/licensing/marketplace/termsfuse>.

6. SUPPORT SERVICES.

Thales Australia will use commercially reasonable efforts to provide web-based and/or email support to you for the App during normal business hours. Thales Australia, and not Atlassian, is responsible for providing all support for the App, and for providing you information necessary for your use of the App. At a minimum, Thales Australia

will respond within twenty-four (24) hours to any support request that Atlassian identifies as 'critical', and in all other cases within five (5) business days of request from you or Atlassian.

7. **OPEN SOURCE SOFTWARE.**

The App contains open source software, including MIT, Apache Licence Version 2.0 and OFL-1.1 licence types (**Open Source Software**). This EULA does not apply to the Open Source Software contained in the App. Rather, the terms and conditions in the applicable Open Source Software license set out in Annexure 1 will apply to the Open Source Software. Nothing in this EULA limits your rights under, or grants you rights that supersede, any Open Source Software license set out in Annexure 1. You acknowledge that the Open Source Software license set out in Annexure 1 is solely between you and the applicable licensor of the open source software. You will comply with the terms of the applicable open source software license set out in Annexure 1.

8. **UPDATES.**

Thales Australia may from time to time make available to you updates, upgrades, supplements and add-on components (if any) to the App, including bug fixes, service upgrades (parts or whole), and updates, enhancements and feature improvements or deletion of the App (including entirely new versions), (collectively **Updates**) after the date you obtain your initial copy of the App. This EULA applies to all and any component of the Updates, unless Thales Australia provide other terms along with such Updates. You acknowledge and agree to install, update and enable any Updates of the App deemed critical by Thales Australia to continue accessing the App. While the Updates will be generally available, in some limited circumstances, the Updates will only be offered by your network carrier, and such Updates will be governed by your contractual relationship with your network carrier.

9. **AVAILABILITY.**

You acknowledge and agree that Thales Australia has the right to modify, suspend or discontinue the App or any portion of the App at any time. Thales Australia may also impose additional limits on certain features and services or restrict your access to parts or all of the App without notice or liability.

10. **INTERNET ACCESS.**

The App requires your device to have access to the internet and may be subject to restrictions imposed by your network or Internet provider. The App will access the internet through your network connection, Wi-Fi or mobile network, which may result in additional charges depending on your payment plan. In addition, your enjoyment of some features of the App through your device may be affected by the suitability and performance of your device hardware or data access. Thales Australia disclaims any and all responsibility for or associated arrangements with your telecommunications provider including network access and data allowances.

11. **CUSTOMER DATA.**

The App presents your Jira Cloud data in a useful dashboard to assist you with the management of agile projects. The App has no ability to modify your Jira Cloud data, and does not store it (other than temporarily in memory or parts of such data in log files). Other than data contained in Thales Australia's log files, your Jira Cloud data is only transmitted between the App and Jira Cloud, and between the App and your web browser.

You grant Thales Australia a non-exclusive, royalty-free, worldwide licence to reproduce, distribute and otherwise display your Jira cloud data by or on behalf of you through the App (**Customer Data**), and to perform all acts with respect to Customer Data as may be necessary for Thales Australia to provide services to you. You are solely responsible for your Customer Data, and you will be liable to Thales Australia and its employees, officers, agents and contractors for any loss or liability suffered or incurred by Thales Australia and its employees, officers, agents and contractors in connection with your breach of this section 11.

The App only retains Customer Data and some tokens required to communicate security – all such data is stored in an encrypted database, is not shared with third parties or used for a purpose other than those required for the App to operate.

12. PRIVACY.

Thales Australia complies with its Thales Australia Privacy Statement available <https://www.thalesgroup.com/en/node/2736109>, in providing the App. By accessing, using, and providing information and materials to or through the App, you acknowledge that you have reviewed, accepted and consent to Thales Australia handing of information in accordance with:

If you become aware of any actual or suspected unauthorised access, acquisition, use, disclosure, modification, loss or destruction of your data, any security vulnerability or any similar issue you must immediately notify Thales Australia using the contact details in section 22.

You acknowledge and agree that Atlassian is not responsible for privacy, security or integrity of your Customer Data collected or processed by Thales Australia or by the App through the Atlassian Marketplace.

13. SUSPENSION; TERMINATION.

Thales Australia may temporarily suspend your access to any portion of the App if Thales Australia reasonably determines that your use of the App is in breach of this EULA. Thales Australia will use reasonable efforts to provide you advance notice of any such suspension but will have no liability to you in relation to such suspension.

This EULA is effective until terminated. Your rights under this EULA will terminate automatically without notice from Thales Australia if you fail to comply with any of the terms and conditions of this EULA. Thales Australia may also cease providing the App and/or terminate this EULA for convenience and without liability, and where Thales Australia elects to do either of those things, it will use reasonable efforts to give you at least 10 days' prior notice.

Upon termination of this EULA, you must cease all use of the App and delete the App. All provisions of this EULA, except for the licence granted in section 2 which terminates immediately, will survive the termination of the EULA.

14. DISCLAIMER OF WARRANTY.

THE APP IS PROVIDED "AS IS" AND ON AN "AS AVAILABLE" BASIS. YOU ACKNOWLEDGE AND AGREE, TO THE MAXIMUM EXTENT PERMITTED BY LAW, THAT THE USE OF THE APP IS AT YOUR SOLE RISK AND THAT THE ENTIRE RISK AS TO SATISFACTORY QUALITY, PERFORMANCE, ACCURACY AND EFFORT IS WITH YOU. TO THE MAXIMUM EXTENT PERMITTED BY LAW, THALES AUSTRALIA DISCLAIMS ALL WARRANTIES EXPRESS, IMPLIED, OR STATUTORY, INCLUDING, BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, ACCURACY, RELIABILITY, ADEQUACY, COMPLETENESS, AVAILABILITY, LACK OF VIRUSES, LACK OF MALICIOUS SOFTWARE OR CODE, QUIET ENJOYMENT, NON INFRINGEMENT OF THIRD PARTY RIGHTS OR OTHER VIOLATION OF RIGHTS. NO ADVICE OR INFORMATION, WHETHER ORAL OR WRITTEN, OBTAINED BY YOU FROM THALES AUSTRALIA WILL BE DEEMED TO ALTER THIS DISCLAIMER BY THALES AUSTRALIA

OF WARRANTY REGARDING THE APP, OR TO CREATE ANY WARRANTY OF ANY SORT FROM THALES AUSTRALIA.

You will indemnify, hold harmless, and, at Thales Australia's option, defend Thales Australia and its officers, directors, employees and agents from and against any and all loss arising from or relating to any third party claim that the Customer Data, or any use of the Customer Data in accordance with this EULA, infringes or misappropriates such third party's intellectual property rights; or for your negligence or willful misconduct, or your use of the App in a manner not authorised by this EULA; provided you may not settle any claim against Thales Australia unless Thales Australia consents to such settlement.

17. LIMITATION OF LIABILITY.

TO THE MAXIMUM EXTENT PERMITTED BY LAW, THALES AUSTRALIA WILL NOT BE LIABLE FOR ANY DAMAGES OF ANY KIND ARISING OUT OF OR RELATING TO THE USE OR THE INABILITY TO USE THE APP, ITS CONTENT OR FUNCTIONALITY, INCLUDING BUT NOT LIMITED TO DAMAGES CAUSED BY OR RELATED TO ERRORS, OMISSIONS, INTERRUPTIONS, DEFECTS, DELAY IN OPERATION OR TRANSMISSION, COMPUTER VIRUS, FAILURE TO CONNECT, NETWORK CHARGES, RELIANCE ON THE ACCURACY OF ANY INFORMATION IN THE APP, AND ALL OTHER DIRECT, INDIRECT, SPECIAL, INCIDENTAL, EXEMPLARY, OR CONSEQUENTIAL DAMAGES EVEN IF THALES AUSTRALIA HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

18. EXPORT RESTRICTIONS.

You acknowledge that the App is subject to export restrictions of various countries. You agree to comply with all applicable international and national laws that apply to the App, including all the applicable export restriction and economic sanctions laws and regulations. You may not use or otherwise export or re-export the App except as authorised by the laws of New South Wales and the Commonwealth of Australia. In particular, but without limitation, the App may not be exported or re-exported (i) into any Australian embargoed countries; or (ii) to anyone (individuals and organisations) on the Department of Foreign Affairs and Trade list of sanctioned targets

or any other restricted party lists. By using the App, you represent and warrant that you are not located in any such country or on any such list. You also agree that you will not use the App for any purposes prohibited by the laws of New South Wales and the Commonwealth of Australia including, without limitation, the development, design, manufacture or production of missiles, nuclear, chemical or biological weapons. If a dispute, controversy or difference arising in any way from this EULA or your use of the App is not amicably settled, it will be subject to the non-exclusive jurisdiction of the courts of New South Wales. Notwithstanding the foregoing, Thales Australia may apply for injunctive remedies.

21. ENTIRE AGREEMENT; SEVERABILITY.

This EULA is the entire agreement between you and Thales Australia relating to the App and supersedes all prior or contemporaneous oral or written communications, proposals and representations with respect to the App or any other subject matter covered by this EULA. If any provision of this EULA is held to be void, invalid, unenforceable or illegal, the other provisions shall continue in full force and effect.
